### Northumberland Goes Wild!

The Wilder Northumberland Network has recently joined the national Rewilding Network, an organisation devoted to working together towards a wilder Britain. Launched just last year by Northumberland Wildlife Trust, the network has big plans to scale up nature recovery throughout Northumberland by increasing connectivity, removing barriers to species movement and creating more space for water, trees and scrub.

The network will also provide members with access to key resources, peer learning opportunities and advice on grazing, surveys and monitoring schemes.

### Nature North

Their vision is for nature to be acknowledged by policy makers, the public and businesses as key to the prosperity, wellbeing and resilience of communities in the North. ### New habitat scheme at Buton Links

Date: 7<sup>th</sup> February 2025

A scheme by Northumberland Estates will provide new habitat for birds and other wildlife to live at an area which is just south of [Alnmouth](#) in the Northumberland Coast National Landscape. It will involve replacement of an old culvert and improvement of the bridleway, raising it above flood level. The project will enable the creation of extended and enhanced areas of saltmarsh, brackish and freshwater habitat, providing habitat for a range of species, such as wading birds like Curlew and Redshank.

The work will look destructive initially, as large machines will be on site in February. Access for the public along the bridleway and Northumberland Coast Path will be maintained throughout the works.

## Nature for People and Place Research – River Wansbeck

Thriving Together have shared information about the **Nature for People and Place research** that NICRE is carrying out in SE Northumberland on behalf of the Environment Agency and Natural England. This research is exploring community use of green and blue spaces along the River Wansbeck, from sea to source (catchment [map here](#)) and they would love insight from as many local organisations as possible.

## Massive Tree Loss at Cragside

Storm Éowyn has destroyed trees, estimated to be in the thousands, at the National Trust's Cragside site. This includes a 150-year-old Douglas fir which fell into Debdon Burn and took staff two days to remove. The NT estate at Wallington also suffered similar losses.



## The Missing Lynx Project – Reintroducing the Lynx to Northumberland

This partnership project between the charities [The Lifescape Project](#), [Northumberland Wildlife Trust](#), and The Wildlife Trusts nationally, is exploring the possibility of reintroducing lynx to Northumberland and the bordering areas of Cumbria and southern Scotland. After a successful tour in 2024, the Missing Lynx Exhibition is going back on the road this year, appearing next at Northumberland College (Kirkley Campus), 24<sup>th</sup> to 28<sup>th</sup> February. ### Community-owned solar farm moves a step closer

Exciting news from Humshaugh, where residents have been granted planning permission to install about 2,000 solar panels to generate energy for the community. The project will produce about half the electricity currently used by the village. Profits will go into a

community fund providing grants to residents wanting to adopt low-carbon technologies. The project is supported by Hexham MP Joe Morris who has asked the energy secretary to review the potential of community energy plans and provide more support. More information [here](#).



## 4. Active Travel

### Borderline Greenway Set to Reopen

A disused Northumberland railway line is set to reopen to the public as a multi-accessible greenway on the 60<sup>th</sup> anniversary of its closure. The first phase of the project is nearing completion with a 5km loop in place between Alnwick town centre and the new Greensfield bridge which was installed in November 2024.



The target date for the reopening is March 29<sup>th</sup> 2025. The eventual objective is the creation of a Greater North Northumberland Greenway Trail, across almost 100 miles of former railway lines and cycle routes. Find out more [here](#).

## 5. Rivers, Sea & Coast



### Sewage Data HQ

Surfers Against Sewage have launched a go-to hub to [find real-time sewage discharge data](#) from across England. It shows the operational status of sewage overflows, but is not designed to tell you if it's safe to enter the water.

There's lots of other data at [Data HQ](#) which is also well worth exploring.

The [Safer Seas and Rivers Service](#) (also from Surfers Against Sewage) provides an alert service designed to inform water users when quality is compromised. It uses water companies' data to provide risk assessments, giving alerts about water safety based on up-to-date information.

## **Warkworth and Amble Rivers Update**

There was an excellent turn out on 3<sup>rd</sup> February at the cricket club, with an update from Julia Chambers and Jamie Day on how the Coquet River testing is going. Warkworth and Amble testers have collected a lot of data, which is being analysed for trends. We also had Angela Woodburn, commercial and legal manager at Warkworth Harbour Commissioners, also talked about her responsibilities.

## **6. Arts and Culture**

**Winter Trees**

## **7. Updates from Groups**

### **Coquet River Action Group**

CRAG is nearly a year old. The volunteers in our member groups have been regularly testing water quality along the River Coquet since April last year, and so CRAG has recently undertaken a 'road-trip' from Warkworth to Rothbury via Felton to give some feedback to the testers on the data they have collected.



The headline message is that the river is generally in good health. However, in each region there are a few concerns – a sewage treatment works or septic tank that is spilling sewage into a burn, or a burn with high mineral content from erosion or agricultural fertilizer or from an old mine site. This gives us something to investigate further in the current year to ensure that we keep our river healthy. The presentations from the road-trip will be available on the CRAG website from the end of February.

2025 is shaping up to be an interesting year for CRAG. We are keen to undertake some E. coli testing to ensure that the river is safe for bathers, and we hope to use this information to support a bid for bathing water status for Little Shore in Amble. We hope to work with anglers and other groups to start surveying riverfly (invertebrates living in the river) because this is the

best measure of the overall health of the river. We are hoping to link up with other organisations, including Northumberland Rivers Trust, to survey and remove invasive species from the Coquet catchment. And several organisations (the Environmental Agency, the Northumberland Wildlife Trust, Stronger Shores) have approached us to see if we can work together on some mutually beneficial projects. We will let you know more about these opportunities as they develop.







## Heritage Buildings in Berwick - Adapting to Climate Change



### Community Foundation

Up to £500,000 is being made available to community organisations across Tyne & Wear and Northumberland for environmental and climate-related projects. Rewilding programmes, recycling and repurposing projects, raising awareness in communities, and improving the

### Community Foundation - Climate Action Fund

The [Climate Action Fund](#) will be inviting applications for large-scale projects (minimum £500,000) that link climate action to the everyday lives and interests of local communities, or which have a wider influence through linking up groups nationally across different locations.

Funding will be for partnerships led by community/volunteering organisations or public sector organisations. So, if your group has a big idea and can partner up with others, this could be worth looking at. The deadline is yet to be announced but will be sometime this Spring.

### NCC Environment and Climate Fund – closing date February 21<sup>st</sup>



Northumberland County Council is offering £50,000 from its Environment and Climate Fund 2025 to community and voluntary groups in the county.

The Fund was launched at an event at the Cramlington Hub, which showcased how previous applicants had used the money to deliver their projects.

Groups can apply for grants ranging from £250 up to £5,000 to help fund projects which enhance nature and reduce greenhouse gas emissions.

The fund aims to engage the public on environmental matters and encourage active participation.

The fund is open to community groups, charities, clubs, CICs, social enterprises, town/parish councils, and faith groups (projects must be open to all) and the deadline for applications is February 21<sup>st</sup> and applicants can find all the necessary guidance, terms and conditions and an application form at <https://www.northumberlandnetzero.uk/apply/climate-fund>

### New Air Quality Strategy Approved

Northumberland County Council has given approval for a new Air Quality Strategy to improve public health and the environment. The initiative aligns with the council's environment policy and net zero targets to address air pollution and protect nature. It will focus on reducing road pollution, integrate air quality considerations with planning and construction and enhance monitoring systems.
